Town House:

- Efficiency Maine Funding Opportunity: The Town does not have any upcoming projects that would meet the qualifications for this funding.
- Town of Rangeley Service Contract FY 23/24: The Board reviewed and signed the Fire and Solid Waste contracts.
- Quarterly Meeting-Fall 2023: Will discuss STR and Maine High Peaks-National Wildlife Refuge. Date to be determined.
